	PRESENTATIONS & DELEGATIONS
SUSTAINABLE TRANSPORTATION PARTNERSHIP OF THE CENTRAL OKANAGAN	Rafael Villarreal, Sustainable Transportation Partnership of the Central Okanagan (STPCO) and Stephen Power, Lead Consultant, HDR, presented the Draft Regional Transportation Plan, Draft Regional Bicycling and Trails Master Plan and the Draft Regional Disruptive Mobility Strategy.
(STPCO)	The Regional Transportation Plan (RTP) identifies transportation projects and priorities that will help build and maintain a healthy connected future for the Central Okanagan.
	The RTP establishes a framework of priorities over the next 20 years so communities can plan and seek funding collaboratively, as a unified region. The plan was developed following more than two years of technical studies, consultation, and region-wide partnership and collaboration. Consultation with residents across the Central Okanagan, from Peachland to Lake Country, since 2018.

SUSTAINABLE TRANSPORTATION PARTNERSHIP OF THE CENTRAL OKANAGAN (STPCO) CONT. Goals for West Kelowna, Westbank First Nation, RDCO West and Peachland:

- Town Centre land use intensification
- Hwy 97 Park and Ride
- On-Demand Transit
- RapidBus Extension to Peachland as ridership warrants
- Westside Road ongoing safety upgrades and maintenance

It was noted a mobility hub for Peachland, with a strategy for on demand transit, would help build a case for rapid bus extension to Peachland.

Next steps include the final public engagement and revised plans brought for endorsement in fall 2020.

It was noted that:

- The time line of the Regional Transportation Plan (RTP) was reviewed
- The RTP identifies transportation projects and priorities that will help build and maintain a healthy connected future for the Central Okanagan
- The long range plan establishes a framework of priorities over the next 20 years
- Have been consulting with residents across the region since 2018
- With COVID-19 the situation is evolving but the RTP can help map a road to recovery
- Goals of the RTP include safe, efficient, sustainable, affordable and accessible transportation
- The RTP reviewed demographics, travel patterns, conditions and emerging trends
- The population within walking distance of regional transit is expected to more than double by 2040
- Options considered included light rail transit, lake ferries and rapid transit with both the light rail and lake ferries deemed not feasible with costs and population densities
- Rapid bus upgrade would make easier phasing for the light rail in the future
- Integration of mobility hubs to help build a case for more frequent transit, this would include on demand transit
- A policy guidance agreement intended to provide support of funding and grant applications by all members within the partnership
- Many potential projects are on the highway which will require further study and involvement with MOTI and BC Transit
- A mobility hub for Peachland, with a strategy for on demand transit, would help build a case fro rapid bus extension to Peachland
- Regional Bike and Trails Master Plan aligns with the Regional Transportation Plan
- Goals are to increase mode share and reduce emissions
- The primary network needs upgrading, proposing close to 200 kms of bike lanes and paths
- The Westside Trail is listed as one of the high priority projects
- Need engagement to lobby senior levels of government for funding
- Regional Disruptive Mobility Program aims to shine a light on new technologies and system adaptation
- Funding will be challenging with gas tax diminishing as use of electric vehicles reduces amount of gas used

SUSTAINABLE TRANSPORTATION PARTNERSHIP OF THE CENTRAL OKANAGAN (STPCO) CONT.

 Next steps include the final public engagement and revised plans brought for endorsement in fall 2020.

Discussion ensued relative to:

- The intent is for all members of the RDCO to support each individual community's own application for a grant when the grant is part of the regional plan
- People staying home during the Covid-19 pandemic may delay the plan but the delay is unlikely to have a significant effect – larger centres already rebounding
- Riding a bicycle to West Kelowna safely should be a priority, and
- The Westside Trail is a key project in the Transportation Plan, but funding for a design with regional consistency is needed
- Water taxi involves a lot of cost
- School District partnership, cycling promotion at a regional level, along with the sub-committee for plan implementation will be transferring from SPCO to the RDCO.

SHAUN REIMER, SECTION HEAD -PUBLIC SAFETY & PROTECTION, OKANAGAN SHUSWAP DISTRICT, MINISTRY OF FORESTS, LANDS, NATURAL RESOURCE OPERATIONS, & RURAL DEVELOPMENT Shaun Reimer, Section Head - Public Safety & Protection, Okanagan Shuswap District, Ministry of Forests, Lands, Natural Resource Operations, & Rural Development presented information regarding the levels of Okanagan Lake, the water release process and calculations, maintaining fish flows and weather uncertainty.

It was noted that:

- Three out of the past four years have been challenging
- Reviewed the history of the lake and flows from the mid 1930's
- Infrastructure designed to drain lake faster than it would naturally
- Infrastructure consists of 4 dams, 17 vertical drop structures, 3 sediment basins and 38 km of engineered channel
- The watershed is tributary to Columbia River
- Okanagan Basin Implementation Agreement was signed in 1976 by both the Federal and Provincial governments
- Lake level decisions are usually made with a computer model
- Forecasts levels are based on inflow forecasts from the River Forecast Centre and a Release Schedule from Okanagan Lake Dam
- Peak spawning dates and temperature data to inform of fish hatching and emergence, impacts water flows
- Inflow forecasting starts in February with snow weight monitoring
- When higher flows occur there is significant erosion
- The US cannot make us release or reduce flows
- The 2020 snow pack was high, especially on east side of the lake, average on west
- Annual targets are in place to balance flood and drought
- Severe impact on fisheries and ecosystems if mismanaged
- Flood would impact approximately 3600 acres of crops north of Oliver so supply and flooding need to be taken into account.

Discussion ensued relative to:

- Climate change has effected the forecast greatly
- Water coming more quickly and peaking earlier
- Maximum release out of the lake is 11 cm per week governed by the channel size down through Osooyos
- Could potentially manage the lake at higher pool, as was done in 1950's, but human nature means people build lower and closer to lake level
- Climate change means more variability in drought not just flood, the lake could end up too low
- A better way needs to be found for forecasting
- A new Okanagan Basin study should be undertaken as this one is from the 1950's
- Initial Okanagan Basin study involved all levels of government, not just a Provincial ministry.

STAFF SERGEANT DUNCAN DIXON, M.O.M., RCMP Staff Sergeant Duncan Dixon, M.O.M., RCMP presented the Peachland RCMP Statistics for January to March and April to June 2020.

It was noted that:

- RCMP started on a steep path in calls for service, but that dropped as COVID restrictions came in
- More officers have been on the road during the pandemic as leave and training was cancelled.

Discussion ensued relative to:

- Some calls are not noted under action taken as there may not be any action, may be assisting others, or the call may fall under a different category not listed
- Generally major events and trends are included in the action section
- RCMP will respond to any calls but motorcycle noise will not become a priority and the legislation tends to change regularly making it difficult to prosecute
- Crime stats include the Liquor Act and there is potential to add the Cannabis Act
- Preferred course is to refer mental health issues and addiction
- Approximately 80,000 files a year in the Kelowna detachment and many of them with mental health or addiction issues
- RCMP members all receive training in mental health along with identity and ethnicity sensitivity training.

Fire Chief, Dennis Craig presented the RCMP Auxiliary Program (Tier 3)

It was noted that:

• Recommended changes are aimed at keeping the members safer

- RCMP AUXILIARY PROGRAM CONT.
- Some cost changes include uniform, training and medical
- Potential cost for Peachland to participate is \$1,500-\$1,600 per candidate
- Looking for expressions of interest for the program to proceed.

Discussion ensued relative to:

- Number of candidates unknown at this time, reaching out to auxiliary members from 2016
- If costs are higher than anticipated can chose not to participate
- The value is that the program connects police to the community
- Link program from Lake Country to Peachland
- Highest Tier (3<sup>rd</sup> tier) means uniforms more operationally minded, more of a policing look.

Planning & Economic Development Technician, Matt Faucher presented Bylaw No. 2278, 2020 Development & Licence Approval Procedures.

It was noted that:

- The Table of Contents has been updated for ease of use
- Bylaw now includes a time period that conditional approvals will be valid
- Cannabis, retail and non-medicinal licences will require Council approval
- Schedules have been removed and will be stand alone guides for ease of updates and keeping them current with legislation.

DEVELOPMENT & LICENCE APPROVAL PROCEDURES BYLAW NO. 2278, 2020 CONT. Discussion ensued relative to:

- Two bylaws still need to come forward prior to adoption: Building Regulation Bylaw and the Application Fees Bylaw
- Anticipating the two additional bylaws to Council in August with final adoption of all three in September
- Once adopted the District will be able to accept, review and process applications for approval
- The bylaws do not require a public hearing.

MOVED by Councillor Fielding, <u>SECONDED</u> by Councillor Condon:

<u>RC-14/07/20-010</u> THAT Development & Licence Approval Bylaw No. 2278, 2020 be read a first, second and third time.

#### CARRIED.

DEVELOPMENT VARIANCE PERMIT (DVP20-01), 5950 EHLERS ROAD Director of Planning, Darin Schaal presented Development Variance Permit (DVP20-01), 5950 Ehlers Road.

It was noted that:

- The request is to decrease the interior side setback from 12 m to 10.5 m
- The subject property is located within the ALR
- This proposal is to accommodate an egg processing plant
- The variance will only apply to the existing building
- Farm buildings require greater setbacks to provide separation of uses and reduce conflict with neighbours
- Nearest property with a building is approximately 40 m away
- No correspondence from the public has been received.

Discussion ensued relative to:

- Currently there are 2 manufactured homes on the property
- One is property owner's home and the other for the farm worker
- Once the farm building is complete the applicant could pursue permanent status for manufactured homes
- Number of issues delayed construction of initial structure and previous permit lapsed
- ALC regulations have changed since initial application and can no longer build a house of that size
- There are no concerns with the farm building with our bylaws or the ALC
- Recent report to the RDCO states that agricultural land is being misused
- ALC compliance officer has worked with property owner and they meet threshold for agri-tourism.

<u>RC-14/07/20-011</u> THAT Council authorize the issuance of Development Variance Permit DVP20-01 for property located at 5950 Ehlers Road (Lot A, DL 490, ODYD, Plan 18297 Except Plan 30653) to vary Zoning Bylaw No. 2100, s. 7.1.8, to decrease the interior side yard setback for an existing structure from 12.0 metres (39.4 ft) to 10.5 metres (34.5 ft);

AND THAT issuance of the Permit be withheld until a building permit is issued for the existing structure;

AND FURTHER THAT if a building permit is not issued for the existing structure within six months of the date of approval of the Development Variance Permit the approval is deemed to have lapsed.

It was noted that:

 The MTFCC would like the Community Energy and Emissions Plan (CEEP) updated to better fulfill obligations to the Partners for Climate Protection program.

Discussion ensued relative to:

- Staffing capacity is limited
- The plan itself is not a huge time commitment but can not determine how much research will need to occur which the task force cannot assist with
- Council will be receiving a report regarding the Climate Action Coordinator position later in the year
- Not feasible to enact the plan with current work load
- CARIP deadline has been pushed to October
- Funds are still available in CARIP account
- Project must be completed by end of March
- The completed project will result in the Community Energy and Emissions Plan being updated and an understanding of where all emissions come from along with sources and cost, as well as areas where attention should be focused
- Concern that this is not the time and that we are a small community to be taking on such a large project.

GOOSE MANAGEMENT PLAN Director of Community Services, Cheryl Wiebe presented information on goose management.

It was noted that:

• Peachland is a partner of the Okanagan Valley Goose Management Program.

Discussion ensued relative to:

- Creating a bylaw to stop people feeding geese may help
- The only formal control the District has is through the regional program which consists of egg addling
- Have tried decoys, a wine product to spread which is not available any more, a laser and a dog
- Must hold a permit to run any goose deterrent programs
- Allowing dogs off leash for a morning time period along the lake and beach may help
- A sweeper specifically for goose droppings would be approximately \$10,000
- If adding daily goose dropping sweeping, it will take away from other duties such as garden beds and extra garbage pick up
- A drone and many other measures require a licence and/or a permit
- A program to harass wildlife requires a permit
- Extra funding for a student to help with the clean up may help
- Swim Bay is cleared and focused on by staff as part of daily duties.
